



**CANACCORD GENUITY GROUP INC. DISCLOSES
TRANSACTION IN OWN SHARES UNDER
NORMAL COURSE ISSUER BID/BUY-BACK PROGRAMME**

TORONTO, February 11, 2014 – Canaccord Genuity Group Inc. (the “Company”) (TSX: CF, LSE: CF.) wishes to announce that for the period from February 3, 2014, to February 7, 2014, it purchased 114,400 of its common shares through the facilities of the TSX and alternative trading systems pursuant to the normal course issuer bid (NCIB)/buy-back programme announced on August 8, 2013.

The highest and lowest daily average price paid for the purchased shares was \$7.7962 and \$6.6294 per common share respectively and the volume weighted average price per common share was \$7.0343.

The Company has so far purchased 2,320,304 common shares under the NCIB which authorizes it to purchase up to 5,136,948 of its common shares between August 13, 2013 and August 12, 2014. Of these shares, 2,130,748 have been cancelled and the remaining 189,556 will be held in treasury until they are cancelled within the next 60 days.
