



**CANACCORD GENUITY GROUP INC. DISCLOSES
TRANSACTION IN OWN SHARES UNDER
NORMAL COURSE ISSUER BID/BUY-BACK PROGRAMME**

TORONTO, December 22, 2014 – Canaccord Genuity Group Inc. (the “Company”) (TSX: CF, LSE: CF.) wishes to announce that for the period of December 15, 2014, to December 19, 2014, it purchased 25,000 of its common shares through the facilities of the TSX and alternative trading systems pursuant to the normal course issuer bid (NCIB)/buy-back programme announced on August 8, 2014.

The highest and lowest daily average price paid for the purchased shares was \$7.2672 and \$6.6664 per common share respectively and the volume weighted average price per common share was \$7.0330.

The Company has so far purchased 777,649 common shares under the NCIB which authorizes it to purchase up to 5,100,049 of its common shares between August 13, 2014 and August 12, 2015. Of these shares, 354,883 have been cancelled and the remaining 422,766 will be held in treasury until they are cancelled within the next 60 days.
